ABOUT KARTING AUSTRALIA

Karting Australia is the sole body in Australia recognised by the Federation Internationale de l'Automobile (FIA) to organise and control the sport of Karting in Australia.

The power and authority to organise and control Karting within Australia has been delegated to Karting Australia by the FIA through Motorsport Australia (MA). International Karting is controlled by the FIA Commission Internationale de Karting (CIK-FIA). Karting Australia holds a seat on the International Karting Commission.

Karting Australia is a Company Limited by Guarantee and operates under a "Federated Structure" where our affiliated State Associations remain separate legal entities but who's members agree to operate in accordance with all applicable laws and Karting Australia's rules, policies and procedures.

RACING FOR ALL AGES

Under the Karting Australia rules children as young as 6 years of age can obtain their first license. They can start to race at 7 years of age and some continue to compete into their 70's. Very few sports can boast such a diverse range of ages for its competitors.

HOW TO BECOME AFFILIATED

In order to become affiliated with the Australian Karting Association Ltd (KARTING AUSTRALIA), your club must be a member of the State/Territory Karting Association that is affiliated with KARTING AUSTRALIA.

In the first instance, your club must submit an application to your State/Territory Association.

Each application for affiliation should contain:

- Club's current constitution & by-laws (containing the club's objects)
- Completed Membership and Affiliation application form, ensuring each section is completed
- Verification of club's legal status (e.g. Certificate of Incorporation)
- Payment of requisite affiliation fees

If your club wishes to affiliate and does not have all the above listed items, please contact your State/Territory Karting Association to discuss this matter further, as club's can still apply to affiliate, however, some additional documentation may be required to be submitted.

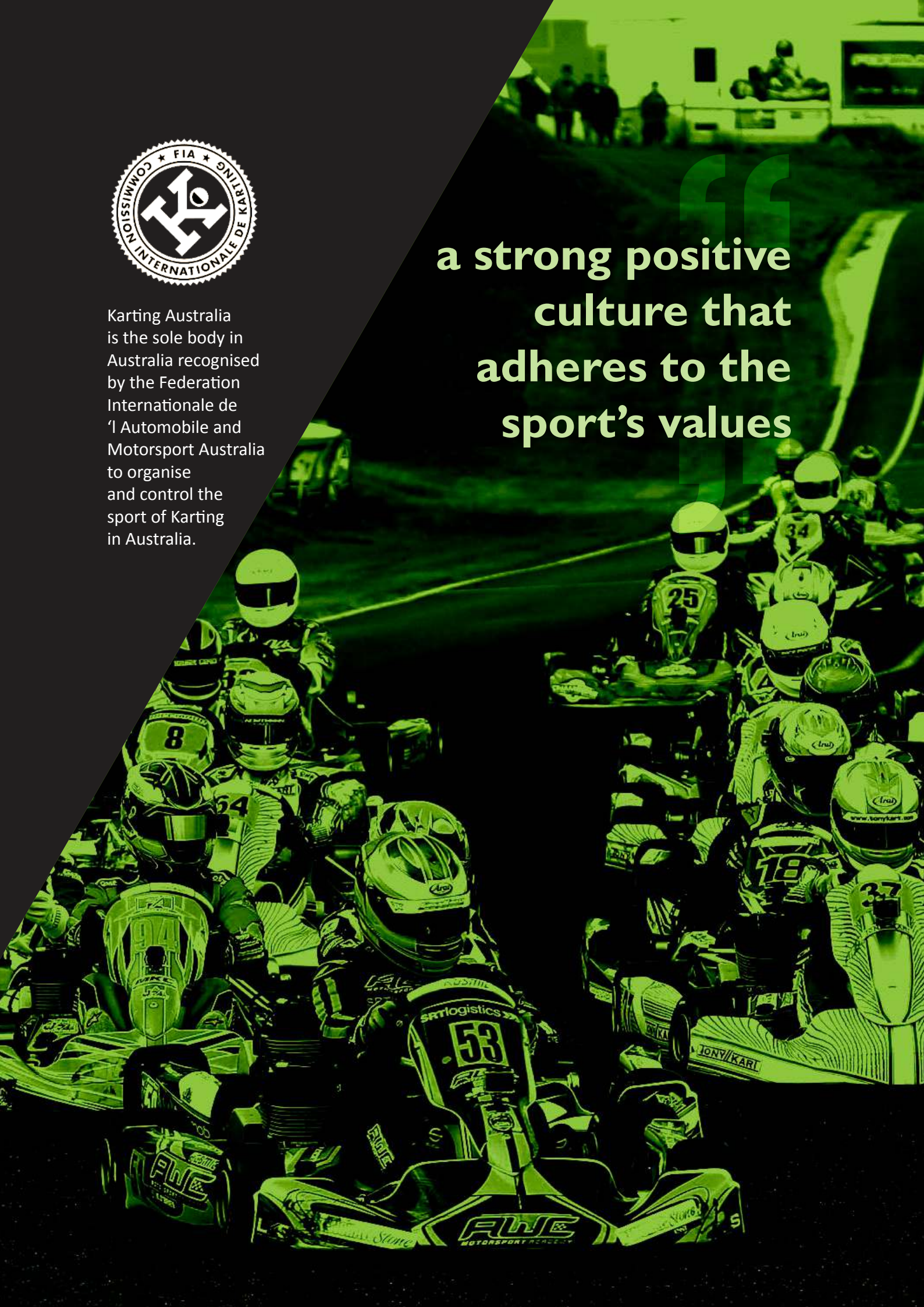
Approval of a club's application for membership must be considered by the relevant State/Territory Association in accordance with its Constitution. Clubs seeking membership must agree to accept and comply with the State/Territory Association and Karting Australia's Constitution, Rules, Regulations, instructions, Policies and Procedures.

Once you have submitted the relevant paperwork on behalf of your club (referred to above), your club's affiliation status will be determined at the next meeting of your State/Territory Management Committee/Board (e.g. Queensland based club affiliations are subject to consideration, confirmation by Karting Queensland – the Karting Australia affiliated body in that State).

BENEFITS OF AFFILIATION

Affiliation with your Karting Australia State/Territory Karting Association brings with it access to the benefits of being affiliated with Karting Australia, including but are not limited to:

- Affiliation with Australia's only karting association with delegated authority from and recognised by both Motorsport Australia and the world governing body of motorsport the FIA;
- Access to the benefits provided by Motorsport Australia under the Delegation Agreement;

- Access to and inclusion in KARM - Karting Australia's Risk Management and Safety 1st programs;
- Access to the CMS for licensing, race management and records;
- Trained and accredited Officials to run race meetings;
- Access to the KARTING AUSTRALIA Track Development Trust loans program;
- Access to any KARTING AUSTRALIA grants programs;
- Access to KARTING AUSTRALIA national and international racing licenses including the ability to race in all Australian States/Territories under a single racing license;
- Access to KARTING AUSTRALIA infrastructure including its Rules, policies and procedures;
- Access to the KARTING AUSTRALIA judicial system;
- Access to KARTING AUSTRALIA Permits and Supplementary Regulations necessary to conduct a KARTING AUSTRALIA sanctioned event;
