

# Penalty Notification – Judge Of Fact

A separate Penalty Notification Form is required for each breach of Rule determined by a separate Judge.

This Penalty Notification is issued in respect of a breach of a Rule as determined by a Judge of Fact at a Meeting which is being conducted under the FIA International Sporting Code and the Rules of Australian Karting Association Ltd trading as Karting Australia.

In accordance with **General Rules, Chapter 7, Rule 20**, “*A Judge of Fact has the responsibility of determining if a ‘fact’- an incident, act, action, event or circumstance has happened.*” The decision of a Judge of Fact is accepted as being final. **No Protest or Appeal may be made against the decision of a Judge of Fact.**
